




#### **Historical New Listings by Month**






#### **Historical Closed Sales by Month**












#### **Historical Average Sales Price by Month**



# **Percent of Original List Price Received**





# **Housing Affordability Index**




This index measures housing affordability for the region. For example, an index of 120 means the median household income is 120% of what is necessary to qualify for the median-priced home under prevailing interest rates. A higher number means greater affordability.


#### Historical Housing Affordability Index by Month




### **Inventory of Homes for Sale**

#### Historical Inventory of Homes for Sale by Month




# **Months Supply of Inventory**
