








#### **Historical Pending Sales by Month**








#### **Historical Closed Sales by Month**



#### Historical Days on Market Until Sale by Month












#### **Historical Average Sales Price by Month**



## **Percent of Original List Price Received**




#### **Historical Percent of Original List Price Received by Month**



## **Housing Affordability Index**




This index measures housing affordability for the region. For example, an index of 120 means the median household income is 120% of what is necessary to qualify for the median-priced home under prevailing interest rates. A higher number means greater affordability.


#### Historical Housing Affordability Index by Month




### **Inventory of Homes for Sale**

#### Historical Inventory of Homes for Sale by Month




## **Months Supply of Inventory**
